REWARDS OF EFFICIENCY: UNLOCKING SAVINGS WITH INCENTIVES



Do you hit the snooze button when someone starts talking about kilowatts, electricity usage, or energy efficiency? It's true—sometimes these can be pretty dry topics. What if you could get serious money back to make your home more energy efficient? And you could continue to keep more cash in your wallet every month because of those efforts?

Here's the Scoop

Federal tax credits and rebates are available for energy efficiency upgrades to your main home. If you've upgraded appliances or made home weatherization improvements to your primary residence since 2023, you may be eligible for tax credits or rebates for energy-efficient improvements. Here's a sampling of what's covered: upgraded exterior windows and doors, insulation high-efficiency (think Energy Star-rated) heat pumps, water heaters, heating and cooling equipment, appliances, electric panel upgrade, and switching to an electric vehicle or adding a home charger.

More Money, More Comfort

So, how does it work? Federal tax credits of up to \$3,200 per year can be claimed with your federal income taxes for the year when the upgrades are made. Just complete IRS Form 5695, follow IRS instructions, and include the form when filing your tax return. You'll need to know the total cost of the upgrades and include relevant receipts. Given how annual total limits are structured, consider spreading your home energy efficiency improvements over a few years. Planning your upgrades can help maximize the annual credit amounts you can claim. As with any tax matter, consulting with a tax professional is advisable.

Don't Leave Money on the Table

While the federal tax credits are managed by the IRS, federal energy rebates are handled by the states. Check **energystar. gov** to see if your energy efficiency improvements qualify for a rebate. Keep in mind, you'll need similar documentation and the total amount spent on the upgrades. Your wallet will thank you for the effort needed to get the cash back! MJM has additional incentives and cashback opportunities such as PowerMoves Rebates on air & ground source heat pumps, heat pump water heaters, and Wi-Fi thermostats at www.powermoves.com.



Play it Again

Let's recap why it (literally) pays to amp up your energy efficiency efforts. Energy-efficient upgrades typically reduce consumption, lower utility bills over time and lessen the environmental impact. Not to mention, you can say adios to drafts and cold spots with energy-efficient windows and doors, and hello to improved indoor air quality with cleaner heating and cooling systems. So, what are you waiting for?

The Bottom Line

MJM wants you to save as much money and energy as possible and can help with your quest for energy efficiency and unlock your full savings potential. Why wait? Federal energy tax credits and rebates may help you score big with energy savings.

OCTOBER IS CYBERSECURITY AWARENESS MONTH

CYBERSECURITY TIPS FOR A SAFER DIGITAL WORLD

Did you know the average household with internet access owns about 17 connected devices? That figure covers a wide range of electronics, including smart phones, computers, streaming devices, smart speakers, home assistants and more. Given our increasing reliance on internet-connected technologies, the likelihood of new cyber threats is ever-present.

MJM is deeply committed to ensuring our local system is safe and secure. We routinely monitor and manage cyber risks, and we work together with other co-ops to share the latest advancements in cybersecurity measures that make us stronger. But you can help, too.

When we all work together to stay safe online, we lower the risk of cyber threats to our systems, online accounts and sensitive data.

October is National Cybersecurity Month, and while good cyber hygiene should be practiced year-round, we'd like to share a few cybersecurity tips to help you bolster your online safety.

- Learn how to spot and report phishing attempts. Phishing occurs when criminals use phony emails, direct messages or other types of digital communications that lure you to click a bad link or download a malicious attachment. If you receive a suspicious email or message that includes urgent language, offers that seem too good to be true, generic greetings, poor grammar or an unusual sender address, it could be a phishing attempt. If you spot one, report it as soon as possible--and don't forget to block the sender. If you receive a suspicious work email, report it to the appropriate IT contact. Suspicious messages that are delivered to your personal email or social media accounts can also be reported.
- · Create strong, unique passwords. When it comes to passwords, remember that length trumps complexity. Strong passwords contain at least 14 characters and include a mix

of letters, numbers and symbols. Create unique passwords for each online account you manage and use phrases you can easily remember. Use a password manager such as Bitwarden, it will make your life easier!

- Enable multi-factor authentication when available. Multi-factor authentication (also known as 2-factor authentication) adds an extra layer of security to your online accounts. These extra security steps can include facial recognition, fingerprint access, or one-time codes sent to your email or phone.
- **Update software regularly**. Software and internet-connected devices, including personal computers, smartphones and tablets, should always be current on updates to reduce the risk of infection from ransomware and malware. When possible, configure devices to automatically update or notify you when an update is available.

MJM RESIDENTIAL ELECTRIC HEAT RATE

If you have recently added electric heating as the primary heating system for your home, you may be eligible for a discounted electric rate.

The electric heat discount is applied November through March at \$0.04063 per kilowatt-hour (kWh) for energy usage between 1,000 kWh and 3,500 kWh for a maximum discount of \$101.58 per month (2,500 kWh X \$0.04063). Regular rates will still apply for the 0 kWh -1000 kWh range and any usage past the 3500 kWh maximum.

Your main source of heat must be electric to receive the discount. (Examples: Electric Furnace, Geothermal heat pump, Air source heat pump, Baseboard)

2025 SCHOLARSHIPS ANNOUNCEMENT

The Illinois Electric Cooperative (IEC) Memorial Scholarship Program awards \$2,500 scholarships annually to deserving students in the "electric cooperative family" entering college to assist them with their educational costs. MJM also awards two \$1,000 scholarships, chosen by a review committee at the Association of Illinois Electric Cooperatives from these applications:

10 scholarships are awarded to high school students who are the child of an Illinois electric cooperative member receiving service from the cooperative.

(Deadline to apply Dec. 31, 2024).

5 scholarships are reserved for high school students enrolling full-time at a two-year Illinois community college who are the child of Illinois electric cooperative members, employees, or directors.

(Deadline to apply Dec. 31, 2024).

1 scholarship, the Earl W. Struck Memorial Scholarship, is awarded to a high school student who is the child of an Illinois electric cooperative employee or director.

(Deadline to apply Dec. 31, 2024).

1 scholarship, the LaVern and Nola McEntire Lineworker's Scholarship, is awarded to a student to attend the lineworker's school conducted by the Association of Illinois Electric Cooperatives in conjunction with Lincoln Land Community College, Springfield, IL.

What is the POWER SUPPLIER DEMAND line on my bill?

Example 1:

Power Supplier Demand

8.49 kW @ 0.00

\$0.00

DEMAND LEVEL:

20kw

10kW

Demand is the power consumption need at its highest at your location for that month's billing period. Simply stated, if you were to turn everything on that you possibly could for 15 minutes, that would likely be recorded as your highest demand for the month. Luckily, most of us only have a few large appliances on at any given time resulting in a much more reasonable Demand outcome. The Power Supplier Demand is 8.49kW in the bill example above; this line item has shown up for about a year now on MJM member's monthly bills currently as a data-only, no charge line item.

Example 2:

DON'T TOWER YOUR POWER. DO LEVEL OUT DEMAND.

In the "Example 2" household, the family begins cooking supper and watching a little TV in the background at 5:00pm. After dinner (6:00pm), some of the family continues to watch TV and the kids do some homework on the laptop(s) while charging it.

At 7:00pm, some housework began with laundry, vacuuming, some gaming for the kids that were done with homework, cell phone charging, laptops charging, EV charging, and some office work/answering emails for one of the parents. This was their highest demand time as all the different appliances or items used created a higher demand (or pulled in more electricity together, at the same time).

At 8:00pm, everyone was settling down and enjoying a show while another load of laundry was running.

How can members reduce Power Supplier Demand (kW) line on their electric bill?

- Spread out the times you use large appliances and charge devices. If you can, start equipment/machines at different times by waiting at least 15-minutes between each start-up.
- Install energy-efficient equipment and find other ways to reduce your energy usage in our Newsletters, website, and other resources like energystar.gov.
- Downsize your equipment to fit the job such as tools/equipment with less horse power.
